Commissioner Bell moved to approve the Emergency Management Performance Grant Award Agreement between the Wyoming Office of Homeland Security and Campbell County, CFDA Number 97.042, DHS Grant Code EMD-2018-EP-00006, Project ID 18-EMPG-CAM-GCF18 with \$35,000 in federal funds and a local match of \$35,000 for the period of October 1, 2017 to June 30, 2019, as presented. Commissioner Avery seconded the motion. All Voted-Aye. Carried.

Commissioner Bell moved to approve the financial institutions as presented, excluding Bank of the West, on the Certificate of Designation of Depositories as designated depositories of the funds of Campbell County for calendar year 2019, pursuant to W.S. 9-4-818(a). Commissioner Shober seconded the motion. All Voted-Aye. Carried.

Commissioner Shober moved to approve the Request for Change in Position Allocation for the CAM-PLEX, changing the currently allocated position of Administrative Assistant I, II, III, band 17/range 39, to an Event Custodian, band 17/range 39, as presented. Commissioner Shelstad seconded the motion. All Voted-Aye. Carried.

Commissioner Shober moved to approve the Road Right of Way Easement between Campbell County and Western Fuels-Wyoming, Inc., providing a permanent road right of way easement across County owned property for access to Garner Lake Road, as presented. Commissioner Bell seconded the motion. All Voted-Aye. Carried.

Commissioner Bell moved to approve up to \$250,000 from County General Funds to provide matching funds for the Gillette College of the Northern Wyoming Community College District to apply for a United States Department of Commerce Economic Development Administration (EDA) Grant application for the purpose of acquiring equipment to be used at Gillette College, with the EDA Grant to be administered by the Gillette College Foundation, as presented. Commissioner Avery seconded the motion. All Voted-Aye. Carried.

Commissioner Bell moved to enter in to an Executive Session to discuss property acquisition and pending litigation. Commissioner Avery seconded the motion. All Voted-Aye. Carried.

The Board reconvened into the Regular Meeting at 10:40 AM.


