Commissioner Reardon moved to approve the Certificate of State Grant-in-Aid between the Wyoming Department of Transportation, Aeronautics Division and Campbell County, State Project No. AGC023X for improvements at Northeast Wyoming Regional Airport in the amount of \$2,500 with no local share, as presented. Commissioner Faber seconded the motion. All Voted – Aye. Carried.

Commissioner Faber moved to approve the Sole Source Purchase Request to purchase radios and radio equipment from Communication Technologies with Wyoming Office of Homeland Security Grant funds in the amount of \$58,412, as presented. Commissioner Reardon seconded the motion. All Voted – Aye. Carried.

Commissioner Bell moved to approve the Memorandum of Understanding regarding the Campbell County Juvenile and Family Drug Court for the Court Supervised Treatment Program, as presented. Commissioner Faber seconded the motion. All Voted – Aye. Carried.

Commissioner Shelstad moved to approve the Maintenance Agreement between Midwest Card and ID Solutions and Campbell County to provide the Salamander System Software in the amount of \$1,260 for the period February 1, 2020 to January 31, 2022, as presented. Commissioner Faber seconded the motion. All Voted – Nay. Failed.
