Commissioner Shelstad moved to approve the Minor Final Plat for Shiplap Estates, Case Number 18.02 COMP, proposing to subdivide 77.77 acres into four lots ranging from 15.9 to 23.53 acres and zoned R-L, Rural Living District, located in a portion of the West ½ Southwest ¼ (lots 3 and 4), Section 18, Township 49 North, Range 72 West, as recommended and

presented by the Campbell County Planning Commission and Department of Public Works. Commissioner Christensen seconded the motion. All Voted-Aye. Carried.

Commissioner Reardon moved to award the Landfill Number One construction of the Final Cover and Gas Collection and Control System to DRM, Inc in the total amount of \$8,699,670.50, as recommended and presented by the Department of Public Works.
