(10-26-2016), Juvenile Case #5167, to which the Campbell County Attorney's Office has a conflict of interest, as presented. Commissioner Maul seconded the motion. All Voted-Aye. Carried.

Commissioner Reardon moved to approve distribution of the Request for Proposals on Architectural Services for the Campbell County Branch Library Phase I Feasibility Study, as presented. Commissioner Shelstad seconded the motion. All Voted-Aye. Carried.

Commissioner Reardon moved to allow for the proposed Chapter 7 Rules for Zoning Regulations Amendments to be open for a forty-five day public comment period, with written comments due by June 28, 2019, and set a public hearing for the 2 day of July 2019 to hear all comments, as recommended by the Campbell County Planning Commission and the Department of Public Works. Commissioner Maul seconded the motion. All Voted-Aye. Carried.



A Public Hearing was held at 10:30 AM for the purpose of hearing a request to enlarge the Bennor Estates Improvement and Service District.


