Commissioners Workshop

The Campbell County Board of Commissioners met for a Commissioners Workshop, Thursday, June 14, 2018 at 8:00 AM.

Present were Mark Christensen, Matt Avery, Clark Kissack, Rusty Bell, Micky Shober, Commissioners; Susan F. Saunders, County Clerk; Breanne Ramirez, Legal Secretary and Robert Palmer, Commissioners Administrative Director.

The Commissioners gave their Board Liaison reports.

Robert Palmer, Commissioners Administrative Director provided updates on the city's request for cleanup and on the one percent survey.

Chairman Christensen arrived at the meeting at 8:25 AM.

Robert Palmer reviewed the upcoming calendar of events, discussed meeting protocol and the agenda items for the June 19, 2018 regular meeting.

Commissioner Shober moved to approve the following hand warrants: Leadership Wyoming – Ivy McGowan-Castleberry for \$2,500; Homax for \$25,180.06; First National Bank – Visa: Extension Office – \$71.72, Children's Developmental Services -\$72.70 and Treasurer's Office – \$47. Commissioner Kissack seconded the motion. All Voted-Aye. Carried.

A workshop was held with Pete Obermueller, WCCA Executive Director regarding worker's compensation.

Commissioner Kissack seconded the amended motion. All Voted-Aye. Carried.
